MODE OF PAYMENT

- All payment should be made in cash/cheque/D.D. only in favour of "Mann Public School", Delhi. All fees are in Indian Rupees only
- Fees will be charged for a full period of 12 months.
- In case the fees is not paid upto 10th of the specified month, a fine of Rs. 5 per day in case of day scholars will be charged. The name of the student will be struck off after one month of the due date of the payment of fees. The student may be readmitted at the discretion of the Principal on payment of all the arrears.
- Two months notice or two months fee in lieu of notice is to be given for withdrawal of a student during the term.
- No separate communication/reminder will be sent by the school for payment of fees/dues.**
